Parade:

The Parade starts at 10:30 a.m. at 1405 E. Main Street near Graff Chevrolet.

Parade participants should line up at 9:30 a.m. Line up in order of arrival.

Big bands line up along Small Hill Street to N.E. 14th Street to Main Street

Schools and floats line up along Pacific Street (near the railroad tracks) to S.E. 14th Street to Main Street. Horses will line up at the end the parade route off of Small Hill Street.

Do not throw candy in front of the judging area. (For viewing and safety purposes.)

Identification: School Banner/Sign/Posters to identify your group. Be sure it is on the left side of the float to identify school for the judges.

Judges location: in front of Jack-in-the-Box on Main Street

Participants Line up: 9:30 am

Parade Starts: 10:30 am

Departure Point: Graff Chevrolet at N.E. 14th Street & Main Street

1st place \$150 plus trophy

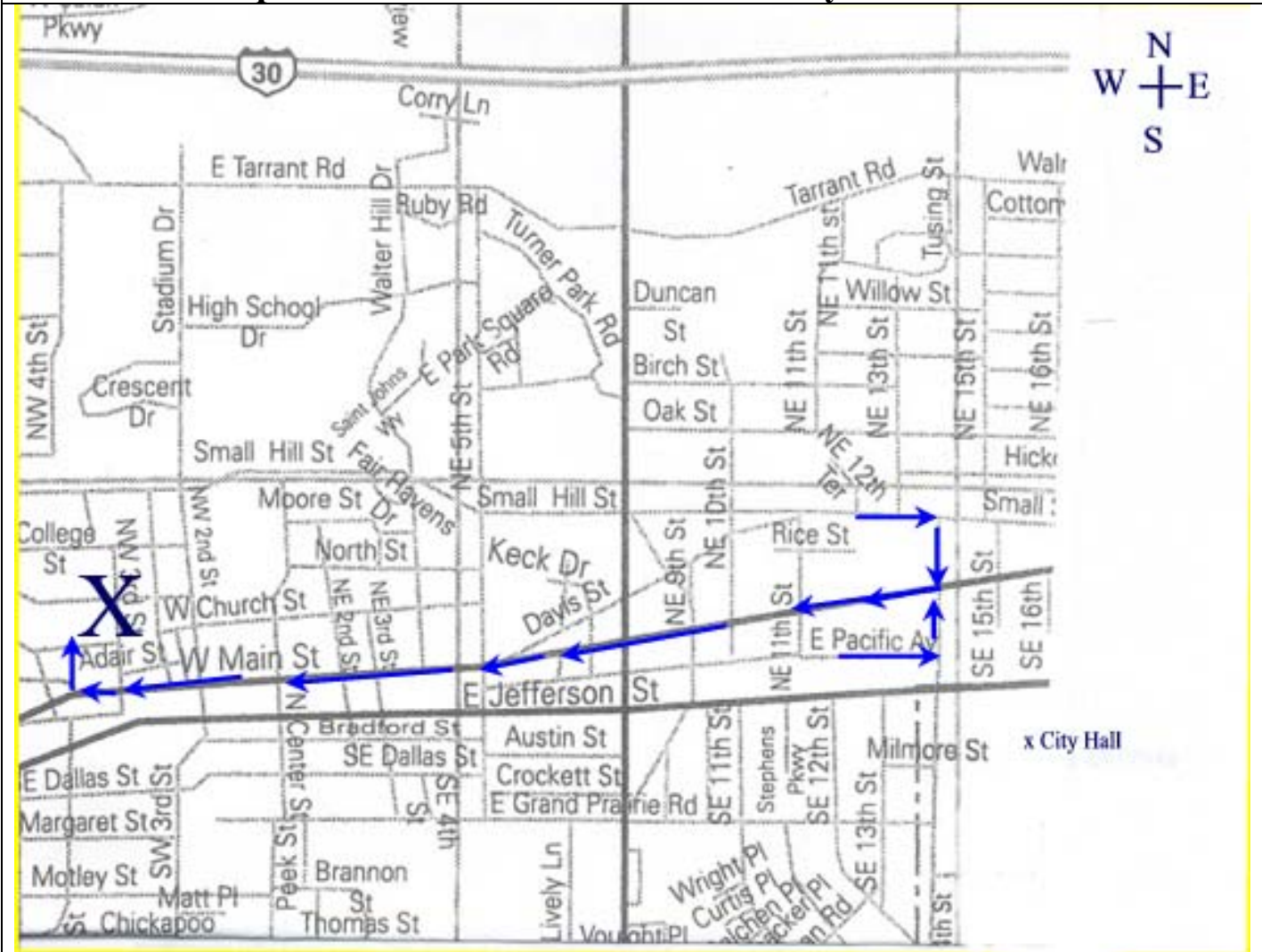
2nd place \$100 plus trophy
