Audit report distributed at our meeting is attached and will be available on the GPISD website. In this report it is noted that "Professional Standards also require that the audit communicate to you the following significant finds and conclusions related to their audit.

Mr Ratcliff noted that all audit information was adequately documented. No difficulties or delays in reporting.

They identified certain internal controls to be material weaknesses and recommended that we keep books quarterly so good financial reports can be given to the board. Board needs timely information for making decisions. Also recommended that we have a specialized account for IRS ie for donations over \$5000 – Schedule B, Special reports for our special events ie Golf, Lone Star Park detailing ticket price, non cash donations, silent auction etc. John Ratliff noted that this was our audit year not our review year. Mr Ratliffs recommendation on quarterly reports to board will be referred to Finance Committee for a Board Recommendation and details on their recommendation.
