Clayton Fisher presented the Investment Account update. It is to be reviewed by the new committee and recommendation brought to the Board.

Denise Clifton recommended that we should adopt the same policy currently in place to use investment proceeds for the current budget as needed. The current policy states that we utilize funds based on a rolling 5-year average of earnings in the investment account.

Bernie Ponzio gave a report from the Fundraising Committee with discussion of several ideas as presented by the committee and board members. Discussion of an event at Lone Star Park was discussed, and Bernie Ponzio was to work on securing a date for Golf Tournament in fall 2021.

MOTION: Motion made by Lesta Watson and seconded by Denise Clifton to pursue details regarding an event at Lone Star Park for Spring 2021. Motion passes.
